**Treasury Report (Renee):** The balance has not changed; it remains at \$3238.35.

**Re-distribute Contact Areas (All):** We decided on having 6 area regions in the state. Leahann and Renee will split region 6 and start calling their assigned regions next week. Kim and Jennifer will make some contacts in their region, as well as Nena for her assigned region. We will report the status of our contacts at the next meeting in July.

**Vice President Update (Leahann):** The board decided to keep the designation process the same and mirror the points system. The renewal process will also remain the same as before with members renewing every 3 years and will receive a renewal certificate. Vice President (Leahann) will reach out to the other members who are designated and see if they want to keep it their designation updated. The designation process will be edited and reviewed and sent over to the Board for input. There is 3 POST Coordinators and Leahann will have them send out our membership flyer to their regions in the state.

**PIO Update (Jennifer):** A training flyer will be posted on our Facebook page to advertise the upcoming training session on June 16<sup>th</sup>. Our website will be updated with the map of 6 regions. Once we have ICPA's history information, the ICPA brochure will be updated and printed for distribution.

**Potential Training for September (Nena/All):** Upcoming training will be held on September 8<sup>th</sup>. Past President (Ed) will reach out to the Attorney General's office for training on retail theft in Idaho to keep it at a state level this year, and look into hosting a training next year on a national scale regarding retail theft. Vice President (Leahann) will look into reserving a classroom at POST Academy for September 8<sup>th</sup>. Training Officer (Nena) suggested we host a Crime Prevention Academy next year like the years past. We will start laying down the foundation/template on what we want to do and plan it from there.

**Next ICPA general meeting (Renee):** Scheduled for Thursday, July 7<sup>th</sup> location TBD. We will discuss what contacts have been made in our regions and possibly find members in the regions to be a lead to help engage for trainings. Determine if we should have our board meetings monthly or quarterly.
